Call to Order: Chair McGinley calls the meeting to order at 7:32 pm

APPROVAL OF MINUTES:

The minutes of August 8, 2024 will be approved at the meeting of November 14, 2024 as the Board did not have adequate time to review.

RESOLUTIONS:

1. **Resolution BOA-2024-014 - Application 2024-11: 83 Fairview Avenue; Block 1502, Lot 49 – R-60 Zoning District**

Granting approval to construct a 120 square foot shed on a corner property in the side yard 2 feet from the side yard property line and 5 feet from the principal structure.

Mr. Ryan makes the motion, **Vice Chair Weston** seconds;

all commissioners in attendance vote in favor; no opposed; no abstentions. **Motion Passes.**

2. **Resolution BOA-2024-015 - Application 2024-08: 48 Durrell Street; Block 1306, Lot 14.01 Zone A-3.**

Granting approval to construct an in-ground pool, and cabana without hardscape

Mr. Ryan makes the motion, **Dr. Cuartas** seconds; all commissioners in attendance vote in favor; no opposed; no abstentions. **Motion Passes.**

NEW BUSINESS:
