Mayor's Report:

Mayor Tamburro attended the Sustainable Verona Electric Vehicle Fair. He thanks the Verona Environmental Commission, the members of Sustainable and the Shade Tree Commission for their involvement in the event. The opening dedication of the Accessible Inclusive Playground was held and he thanks the Township Administrator, Public Works and the Township Engineer for getting the job done. The Mayor then presents the undefeated 10U Verona Barnstormers with Certificates of Recognition for their undefeated, championship season. He then presents a proclamation to the Junior Women's Club for Verona Fights Hunger week. Kareem Rasposo from DCH Acura is present tonight to receive a certificate on behalf of DCH Acura, Verona for sponsoring the Welcome to Verona sign at the intersection of Bloomfield, Pompton and Mt. Prospect Avenues.

Manager's Report:

Township Manager Joseph D'Arco reports the inter-local agreement for fire prevention services with Cedar grove is still pending. Staff meetings for the 2025 budget have been scheduled. Negotiations with the OPEIU have begun and the Township Attorney is working on copyrighting the Township Seal.

R.S. 52:27BB-52: A local officer of member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Division of Local Government Services), under the provisions of this Article, shall by guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000) or imprisoned for not more than one year, or both, in addition shall forfeit his/her office.
