Call to Order:

The Municipal Clerk reads the notice of Open Public Meetings Act.

Mayor's Report:

Mayor Tamburro participated in the truck loading for the Verona Fights Hunger week and thanks all volunteers and everyone involved in the cause. He mentions the new flags and Verona sign donated by DCH Montclair Acura and presented an award at the Verona Festival of Bands. The Mayor comments on the Italian American Flag raising and urges all residents to vote in the November upcoming election. He concludes by thanking all parties involved in assisting with the town's building fire in the Wayland section of town and proceeds with various recognitions.

The Mayor honors the 12U Girls Travel Softball team, in attendance this evening, with a Certificate of Recognition.

Ann Jocelyn, Coordinator of the Municipal Alliance Committee presents the mission of the Committee, one of which is Safe Homes Month in November.

Sponsors of the Veteran's banners are present to receive a certificate of appreciation from the Township.

Essex County Liaison J. Coltre announces the "Strut your Mutt" event taking place in Brookdale Park on October 26th. On Halloween, the Zoo will be having an open house with \$5 emission and candy distribution. On Sunday, November 10th there will be a Road to Wellness Mobile Health Fair at the Cherry Blossom Welcome Center in Branch Brook Park. Holiday Lights will begin on November 22nd and he reminds the public of early voting taking place at the Community Center starting on October 26th.
