**WHEREAS**, the Qualified Purchasing Agent has determined that the value of said services will exceed \$17,500.00; and

**WHEREAS**, this expenditure shall be charged to Budget Account Nos. 4-05-55-502-342 and 4-45-55-502-342 or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds have been contingently certified by the Chief Financial Officer.

**NOW, BE IT RESOLVED** that the Township Council of the Township of Verona, in the County of Essex, New Jersey that W.R. Neumann Company, Inc. d/b/a Miracle Chemical Company, 1151 B Highway #33, Farmingdale, New Jersey 07727 is hereby awarded a contract for the purchase of various chemicals used in the operation of Water/Sewer Utility not to exceed \$44,000.00.

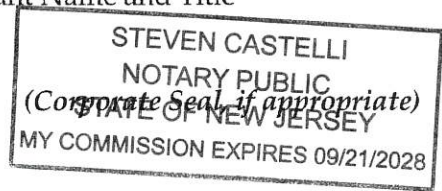
