**AUTHORIZING A CONTRACT WITH ALL AMERICAN SEWER  
SERVICE, INC.**

**WHEREAS**, there exists a need for drainage and sewer services within the infrastructure of Township of Verona; and

**WHEREAS**, the Township of Verona has a need to acquire such services pursuant to *N.J.S.A. 19-44A-20.5*; and

**WHEREAS**, the Qualified Purchasing Agent has determined that the value of said services will exceed \$17,500.00; and

**WHEREAS**, this expenditure shall be charged to Budget Account No. 4-05-55-502 or any other account that may be deemed appropriate by the Chief Financial Officer or her designee, and the availability of funds have been contingently certified by the Chief Financial Officer of the Township pending approval of the 2024 Budget.

**WHEREAS**, the Township Manager has recommended that All American Sewer Service, Inc., PO Box 605, Lodi, New Jersey 07664 be awarded a contract to provide drainage and sewer services on the sewer lines within the Township of Verona.

**THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Verona, in the County of Essex, New Jersey that All American Sewer Service is hereby awarded a contract for providing sewer services not to exceed \$20,000.00 without further authorization of the Governing Body.

**BE IT FURTHER RESOLVED** that the Township Manager and the Municipal Clerk are hereby authorized to enter into an agreement for the aforementioned services a copy of which shall be available for public inspection in the Office of the Municipal Clerk.

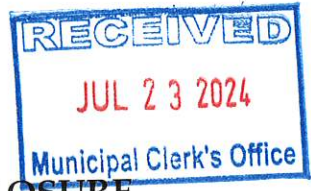
