AUTHORIZING A CONTRACT WITH ESSEX FENCE

WHEREAS, the Department of Public Works requires repairs or placement of various fencing throughout the public lands of the municipality; and

WHEREAS, Essex Fence provides such goods and services; and

WHEREAS, the cost of this purchase shall not exceed the total amount of \$18,600.00 and shall be charged to lines T-90-56-872-002 (\$16,000) and 4-01-28-375-00 (\$2,600).

NOW, THEREFORE, BE IT RESOLVED, that the Township of Verona, County of Essex and the State of New Jersey, as follows:

1. The Council hereby authorizes the Township Manager, or his designee, to execute any and all documents and take any and all actions necessary to complete and realize the intent and purpose of this resolution.
2. The services requested shall not exceed \$18,600 and no services or materials shall be requested without a certification of funds.
3. This resolution and the contract will be on file and available for public inspection at the office of the Municipal Clerk.

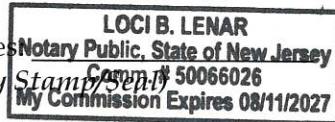
