WHEREAS, on October 17, 2024 the Township of Verona advertised in the Star Ledger for bids for Contract No. 2024-12 – Landscaping & Maintenance Services setting the date for the return of bids as November 21, 2024; and

WHEREAS, on November 21, 2024 the Township of Verona received one (1) responsive and responsible bid for Contract No. 2024-12; and

WHEREAS, Caputo Bros. Tree Service, 325 Bowden Road, Cedar Grove, New Jersey 07009 is the lowest responsive and responsible bidder, for a period of twelve (12) months. The contract may be extended for all or part of four (4) twelve month periods, by mutual consent of the contractor and the Township of Verona at the same terms and conditions as the original twelve-month term.; and

WHEREAS, the Qualified Purchasing Agent has reviewed the proposal and recommends that Contract No. 2024-12 be awarded to Caputo Bros. Tree Service as the lowest responsive and responsible bidder; and

WHEREAS, this contract was advertised and is being awarded as an open-ended contract pursuant to *N.J.A.C.* 5:30-11.10 and there shall be a maximum of 250 work orders as defined in the bid specifications per contract year (twelve-months); and

WHEREAS, the as required amount shall be chargeable at such time as a certification of available funds is made by the Chief Financial Officer upon receipt of a properly executed purchase order.

A RESOLUTION TO SUPPORT PUBLISHING LEGAL NOTICES ON OFFICIAL GOVERNMENT WEBSITES

WHEREAS, the sunset provision of March 1, 2025 imposed under P.L. 2024 c.106 is fast approaching in what was a temporary solution that allowed local governments to comply with the public notice requirements under the law in time for annual reorganization meetings in January; and,

WHEREAS, local government officials serve as the stewards of property taxpayer dollars and should no longer be required to subsidize the newspaper industry with revenues collected from publishing legal notices in the press; and,

WHEREAS, long before NJ Advanced Media's announcement that it was terminating daily print publications in January of 2025, local government officials found it increasingly difficult to comply with the public notice requirements under the law as the media has become almost exclusively digitized and struggled to retain staff, resources, and publications; and,

WHEREAS, legislation that will authorize local governments to publish legal notices on a local government's official website will streamline an antiquated and overly burdensome process and save valuable time, resources, and property taxpayer dollars.

NOW, THERFORE, BE IT RESOLVED that the Township of Verona in the County of Essex, New Jersey does in fact, hereby urge state leaders to pass legislation that will authorize municipalities, counties, school districts, and all local governments to publish legal notices in a clear, transparent, and timely manner on a local government's official website.

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to Governor Phil Murphy, Senate President Nicholas Scutari, Speaker of the General Assembly Craig Coughlin, Senator Kristin M.
