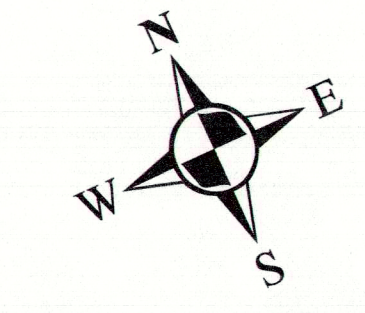

- English units (feet)

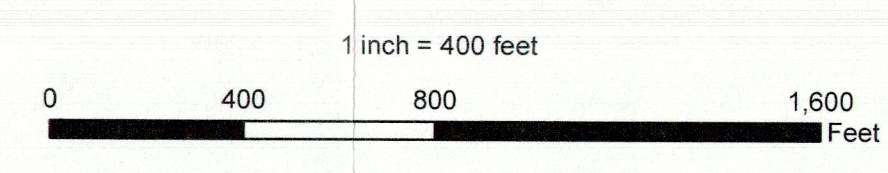
