- Township reserves the right to refuse an application
- Vendor application, fees and required license or permits must be received by 11/22/24
- Vendors will receive a set-up timeframe a week prior event between 10am 11:30am
- All vendors must stay until breakdown time (4pm), early breakdown is not permitted
- Single Space is 10' long to fit a 6' table. Canopy space is 10'x10'. If you need more than one space you must register and pay for two single spaces
- No refunds
- No Rain Date
